- 1) 3-3-16, From the Traffic Commission, amend Chapter 17-119 to allow one hour parking on the northerly side of School Street to a point approximately feet from Washington Street.
- 2) 3-3-16, From the Traffic Commission, add to Chapter 17-115, parking prohibited on the westerly side of Coleman Avenue from East Silver to a point feet south.
- 3) 4-7-16, From the Traffic Commission, Chapter 17-115 delete parking prohibited on Woodmont Street.
- 4) 4-7-16, From the Traffic Commission, Chapter 17-115 delete parking prohibited on Dartmouth Street.

- 9) 3-19-15, A motion by former Councilor Crean, to implement legislation that would allow the Westfield Police Department to enforce noncriminal disposition infractions for recreational and marine patrols.

Committee to amend the City ordinance Chapter 16-152, Public Shade Trees relative to the application and fine fees.
