New Business: Diane Snow made a motion that we grant an exemption to owners of 6 Cottage St for 1 year. With the understanding that it is a one time exemption.

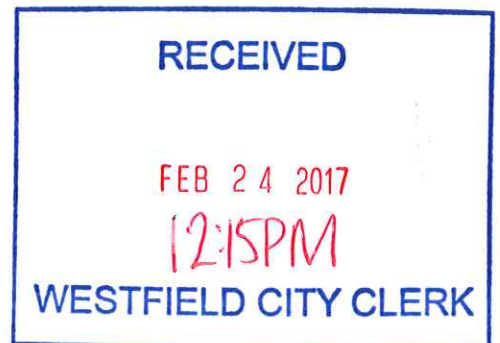
