The Commission on the completion of the oral interview review of your submitted data and along with the back ground check the appointing authority is planning on making a conditional offer of employment at the conclusion of this interviewing process.

The next phase process is the elements for condition of employment which is as follows. You are required to pass:

- · Pre-employment medical screening

- Pre-employment psychological screening
- Massachusetts Human Resources Division 'Physical Abilities Test' (PAT), this is at your own expense \$150.00.

A meeting will be held once everything is completed to make the official appointment and to have the w' Westfield City Clerk give the Oath Of Office.
