PROCEDURE FOR OBTAINING A SPECIAL ALCOHOL EVENT LICENSE

- A special event liquor license (MGL 138, Sec. 14 special license) must be obtained for events that will serve alcohol beverages to the public.
- Applicant must complete and file an application for a special event liquor license with the local License Commission.
- The person stated on the application as "*individual responsible for the activity*" should reflect the person in control of the alcohol served/sold during the event.
- Tickets may be sold to the public for an event when a Sec. 14 license is in place.
- Alcohol for the event must be purchased at a liquor distributor/wholesaler, not at a package goods store.
- The fee for a special alcohol event license is ~~\$100.00~~
- **AN INSURANCE BINDER, PROVIDING LIQUOR LIABILITY COVERAGE FOR THE DAY OF THE EVENT, MUST BE OBTAINED AND A COPY OF THE INS. BINDER MUST BE ATTACHED TO THE APPLICATION.**
