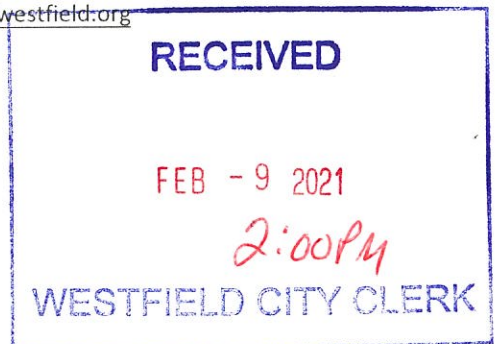
A regular meeting of the Westfield School Committee is scheduled for Thursday, February 11, 2021, at 5:30 pm.
