- I. Call to Order and Roll Call- Gabrielle called the meeting to order at 6:11PM

- II. Discussion with our featured guest, Jynai McDonald, Family Child Care Coordinator for SEIU Local 509. Discussion centered on the importance of Family Childcare Providers, a workforce of over 92% women, a large percentage of whom are women of color. The Common Start Coalition has a bill before the legislature for a more sustainable, long term model with direct funding to providers based on capacity not on attendance. This bill also provides for assistance for families at lower wage levels. Jynai hopes for our support.
