AGENDA ITEMS

1. From 12/20/18: Upon motion of Councilor Morganelli, it was VOTED: To inquire on the nature of current fire extinguishing product use and composition of the product at Barnes Air Field and to determine if Federal Aviation Administration (FAA) regulations require the discharge of AFFF on Barnes Municipal Airport property for fire equipment testing or for the "live-fire drill" component of FAA re-certification. REFERRED TO PUBLIC HEALTH AND SAFETY COMMITTEE and AIRPORT COMMISSION

Summary & Action Taken:

- Councilor Babinski restated the comments of Airport Manager, Eric Billowitz from 5/30/19 regarding FAA regulations
 - a. The answer to the FAA requirement question is no. In a joint-Use setting, the FAA does not require any discharge demonstration as part of our annual Certification Process
 - b. He had an inquiry into the Air National Guard relative to the question posed. Has not received info as of 5/30/2019
- Councilor Babinski reported comments received from the Airport Manager on November 18, 2019, and the ANG Fire Chief on November 25, 2019.
 - a. Airport Manager reported that in their discussions with the Guard, they have indicated that they do not use AFFF for drill. He suggested I reach out to the ANG Fire Chief, Travis Raby.
 - b. In a Follow-up Conversation with ANG Fire Chief Travis Raby, it was stated that the ANG has been directed to use any other methods besides AFFF when

possible. No training/practice sessions have taken place at the base in at least the last 20 years.

- Councilor Babinski read two quotes found on the website. She suggested that those wishing additional information visit the ANG website:
 - a. "In November 2015, more environmentally responsible AFFF formulas were added to the DOD's qualified products list for firefighting agents. The Air Force began replacing both PFOS-based and other legacy AFFF products with a new, environmentally responsible formula in August 2016. The Air Force completed new foam delivery in August 2017."
 - b. "The Air Force is taking steps to guard against future contamination by replacing legacy AFFF stockpiles with a foam that reduces PFOS/PFOA exposure, Phos-Chek 3 percent, six carbon chain AFFF"
